„Birthday Card for the Teddy Bear”

On the occasion of the holiday of the Teddy Bear, an extraordinary friend of all children, which falls on November 25, we invite children from kindergartens and schools from all over Poland and Europe to give the Teddy bear colorful birthday cards.

„A teddy bear is an inseparable companion of every child. It is a friend with whom we feel safe, with whom we discover the world. It is an image of what is best in every human being. It sends a constant message to us adults that every child has their own rights that should be respected. It also reflects the most important values that determine the path of development of each child” (from the Development Concept of Kindergarten No. 9 in Tychy for 2018-2023).

A brief historical overview:

World Teddy Bear Day was established exactly on the centenary of the mascot - in 2002. It all started much earlier, however. In 1902, the President of the United States, Teodor Roosevelt, went hunting. After several hours and no success, one of the president's companions shot a baby bear and took him to Roosevelt. The president, seeing the terrified animal, ordered it to be released immediately. One of the witnesses to this event immortalized the story of a bear in a drawing in a Washington newspaper, which was read by a toy manufacturer ... From that moment, the diminutive name of the president was used and mascots were sold under the name Teddy Bear, which today in English is the term for all plush toys.

RULES OF THE COMPETITION

Objectives of the competition:

- • introducing the youngest to the figure of the Teddy Bear
- • arousing curiosity about the world
- • developing the emotional (empathy) and social spheres
- • encouraging the learning of foreign languages
- • shaping and developing artistic interests
- • developing manual skills of children
- • shaping invention and creative imagination
- • developing aesthetic sensitivity

Competition participants:

The competition is aimed at children aged 3-9.

- Competition works:
- **the contestant's task is to make a birthday card for a Teddy Bear,**
- **The teddy bear should wear a national costume or hold the flag of the participant's country of origin,**
- **the card should contain short birthday greetings for Teddy Bear in English (preschool children can be helped by their guardians),** any technique can be used for the work,
- A4 or A5 format of works,
- works should be done individually and by children themselves,
- each contest participant may perform only one work,
- a facility taking part in the competition may provide a maximum of 3 works,
- a declaration of parents / legal guardians (Annex 1) should be attached to each submitted work,
- the work taking part in the competition must contain a certificate on the back (name and surname of the author of the work, age, name and surname of the teacher, name and address of the facility, telephone number, e-mail address),
- participation in the competition is tantamount to transferring the copyright to the Organizer. The works will not be returned to the Authors.

Deadline for submission of works and results:

Competition works should be submitted by November 19, 2021.

The competition will be adjudicated on November 25, 2021. Information on the results of the competition will be available on the website of the kindergarten

The winners will also be notified by e-mail to the e-mail address provided in the application form.

- The works will be assessed by a committee appointed by the organizers, in three age categories: 3-4 years old, 5-6 years old and grades 1-3 of primary school.
- There will be places selected for each age group (I, II, III).
- When evaluating the works, the following factors will be taken into account: independence of execution, creativity, degree of difficulty of the chosen technique as well as diligence and aesthetics of execution.
- Diplomas and prizes for 1st, 2nd and 3rd place as well as distinctions will be awarded in each age group. In-kind prizes and commemorative diplomas for the winners will be sent by post to the address of the winning institutions. The rest of the participants will receive their children's diplomas by e-mail and a thank you to the teacher for participating in the competition.
- After the end of the competition, an exhibition of the submitted works will be organized, which will be available on the Facebook page of Kindergarten No. 9 and Primary School No. 36.

Information clause

1. The data administrator is Kindergarten No. 9 for them. Teddy Bear in Tychy.
2. The data is processed in order to participate in the competition "Birthday card for a plush bear" in accordance with your consent and the regulations. In the field of publication of the work, the data is processed on the basis of the consent of the parent / legal guardian, for promotional purposes.
3. The legal basis for data processing is Art. 6 sec. 1 lit. a GDPR and art. 81 of the Act of February 4, 1994 on copyright and related rights - with regard to the use of the image.
4. The consent to the processing of personal data is voluntary. It can be withdrawn at any time, which will make it impossible for your child to participate in the competition. Granting consent for the publication of your child's work is voluntary. Lack of such consent will result in the inability to publish your child's work in information materials prepared and disseminated by the Kindergarten No. Pluszowego Misia in Tychy, in terms of the implementation of the competition.
5. The data will be processed for the duration of the competition.
6. You have the right to access the content of the child's data and the parent's related data and the right to rectify, delete, limit processing, the right to transfer data, the right to object, the right to withdraw consent at any time without affecting lawfulness of processing based on consent before its withdrawal.
7. Personal data are not subject to automated decision making, including profiling.
